- **Buffet setups:** Up to **3 hours** from the ready time.
- **Mini buffets, bento sets, and packet meals:** Up to **1 hour** from the ready time.

Additionally, to align with these updated safety parameters and minimize the risk of food contamination, **we will no longer provide takeaway boxes for packing leftover food.**

Should you wish to take full responsibility for extending the consumption duration or packing leftover food beyond the prescribed timeframe, we kindly request that you review, sign, and return the attached indemnity form.
